Provides students with a solid background in the biological basis of behaviour. Animal and human research topics will include functional neuroanatomy and neural signalling. Further topics may include sensory and motor control, motivational systems, hormones, and emotions, among other topics.

If you cannot submit a VOI due to limits on terms of use, you can submit a different form (like a letter from a doctor), as long as it is an original document, and it contains the same information as the VOI (including dates, academic impact, practitioner's signature, phone and registration number).
